



# MidasMart. Midas Mart Cooking Contest 2026 Terms and Conditions

## 1. Contest Mechanism

1.1. The contest will be held in 3 rounds, followed by a finale.

a) **First Round:** 10 participants will compete on **16 May 2026**

b) **Second Round:** 10 participants will compete on **8 August 2026**

c) **Third Round:** 10 participants will compete on **12 September 2026** d) **Finale:**

The top 3 winners from each round (9 participants) will compete in the **Finale on 21 November 2026**

## 2. Registration Period:

2.1. **First Round:** 10 April – 09 May 2026

2.2. **Second Round:** 18 June - 29 July 2026

2.3. **Third Round:** 06 August – 05 September 2026

2.4. **Finale:** Selected participants from the first three rounds will be contacted

## 3. Contest Date, Time & Location

3.1. Date: 16 May 2026, 8 August 2026, 12 September 2026, and 21 November

2026 3.2. Time: 11.00AM – 3.00PM

3.3. Location: Midas Mart, S'MART Pandan

## 4. Eligibility

4.1. This contest is open for Midas Mart's customers only.

4.2. Spend a minimum of RM100.00 and above in a single receipt within the "Registration Period" at Midas Mart, S'MART Pandan or @Mart Kempas to participate.

4.3. Each participant is only eligible to participate **once** throughout the contest. Participants and their assistants who have taken part in any of the contest rounds are **not allowed** to compete in subsequent rounds. **Exception:** Shortlisted winners in Round 1 – Round 3 may advance to the **Final Round**.

4.4. Employees of Midas Mart and S'MART, S'MART's tenants, their immediate family members (spouse, children, parents, and siblings), and anyone directly connected with the contest are **not eligible** to participate.

### 5. Contest Registration

5.1. Registration must be submitted within the “Registration Period” via Google Form at the following link:

5.2. Attach Midas Mart purchase receipt in the contest form to qualify your entry.

5.3. Ensure that all details in the contest form are correct. Incomplete forms will be disqualified.

### 6. Selection of Participants

6.1. Only the first **10 eligible registrations** for each round will be selected.

6.2. Midas Mart will contact participants via the contact number provided in the contest form.

### 7. Attendance & Replacement

7.1. If a participant cannot be contacted or fails to attend the contest, their slot will be given to another participant.

7.2. Registered participants **must** attend personally. Representatives are not allowed.

### 8. Assistance

8.1. Each participant may bring **one (1) assistant** to help during the contest.

### 9. Cooking Requirements

9.1. Participants must bring their own cooking and equipment, such as pans, pots, ladles, and cutlery, for use during the contest.

9.2. Midas Mart will provide each participant with **one (1) gas stove only** and all the necessary cooking ingredients for the contest. Participants must prepare their dishes solely using the ingredients provided.

9.3. Participants are strictly prohibited from bringing and using their own ingredients. Any participant found doing so may be disqualified at the discretion of the Management.

### 9.4. Round 1 – Round 3

- a) Each round will be conducted based on a specific cooking theme as below:
  - **Round 1:** Local Cuisine
  - **Round 2:** Korean Cuisine
  - **Round 3:** Western Cuisine
- b) Each participant is required to prepare **two (2) main dishes** within a **2-hour time limit**.
- c) Cooking ingredients will be provided in each round for participants to select and use.
- d) The ingredients provided are on a **first-pick first-serve basis**.
- e) Each round will include **designated ingredients**. Participants are required to incorporate the provided ingredients into their dishes.
- f) Failure to include any of the mandatory ingredients will result in **deduction of points**.
- g) Participants must ensure that their dishes are aligned with the assigned theme of the round.
- h) Creativity is encouraged in presenting dishes while adhering to the theme and ingredients provided.

### 9.5. Final Round

- a) A "**black box**" containing a surprise selection of ingredients and a designated menu will be provided to each participant.
- b) Each participant will **draw a number** to determine which black box they receive. The draw is **final** and cannot be changed.
- c) Each black box will include the menu for **two (2) main dishes** that must be prepared, along with **one (1) free-choice dessert**.
- d) Participants are required to cook all **three (3) dishes** within a **2-hour** time limit.
